- 2. Closed Session—Contract Negotiation
  - a. Started at 1205 pm.
  - **b.** Met with District on Tuesday. All counters were in District's hand, and they gave us back 4 to 5 counters.
  - C. Articles 2, 6, 7, 11, and 16. Tentative agreement on 2, 6, 9 and 12.
  - d. Big disagreement on 7 (salaries) and 16 (staffing).
  - **e.** 5% the first year, 4% next year. They kept the COLA language. We would try to counter with 6% and 5%.
  - f. 401K: 0.5% (District), countered by 1% (EA) with CPI increase each year.

- **Q.** Retro back 4 pay periods (District), EA countered with first pay period of July.
- h. 60% of filled vacancies would be LTCE.
- i. Pace we were meeting is going to be even slower.
- j. May have to get to impasse.
- k. We will proceed with election, but transfer will be after the contract is ratified. Cap of extension will be 3 months.
- I. Nominating committee: Virginia, Andrea, Chris.
- **m.** Need membership vote, after EA Board recommendation. Thus, will need to hold a general membership meeting for the vote.
- n. Everyone is ok with 3-month extension.
- O. Jack motioned to vote on recommending this to general membership. Grace seconded. Everyone said ayes.
- **p.** General membership meeting would be about the election, position extension, and contract negotiation update.
- **Q.** Need to find out more about the timeline about possibility of impasse.
- r. Impasse means standing our ground.
- S. 3 ongoing PERP charges against the District.
- t. Ends at 1257 pm.
